## Tuition Rates:

- Infant Room...\$205 per week
- Movers Room...\$205 per week
- Toddlers...\$190 per week
- Pre K 2/3...\$180 per week
- Pre K 3/4 ...\$170 per week
- Pre K 4/5...\$160 per week
- School Age...\$100 per week after school only
- School Age...\$125 per week before and after school
- School Age...TBD for summer camp, based on field trip plan
- Drop in rate for non enrolled students of any age...\$64 a day
- Drop in defined- any child attending less than twice a month. If a child attends more than twice a month, they must enroll as full time, and be charged as a regular student.
  - Please note rates are based on the classroom the child is enrolled in not the age of your child.

## Other fees:

- Non-refundable \$50 enrollment fee that will hold your child's spot in care for up to 2 weeks. Must be paid prior to start date.
- If your child is dropped and later re-enrolled a new enrollment fee will be charged.
- Late pick up fee for any child picked up after 6:00p.m. \$15 up to 15 minutes 1-15. After 6:15 it is \$2 a minute due by the end of the week.
- Three late pick up fees can result in termination of services
- Late payment fees \$35 after Monday
- School-age parents must call and let Connect know if we will not be picking your child up from school in the afternoon. If we are not notified we will charge your account \$5.
- Annual registration fee of \$50 per child with no family paying more than \$100 due by March 15<sup>th</sup> every year.

## Discounts

- Active duty military will be given a 10% discount per child enrolled
- Promotional discounts will have a expiration date

## Vacation Time

- Once a child has been enrolled at Connect for 12 consecutive months, your family will be eligible for vacation weeks in which your child will not attend and you will not pay tuition:
- After your child has been here 2 years you will be eligible for Two Weeks Vacation
- After your child has been here 3 years you will be eligible for Three Week Vacation
- A Vacation Request Form must be submitted through the [www.connectafc.com](http://www.connectafc.com) website
- at least 2 weeks PRIOR to the beginning of your vacation week.
- Only two families will be approved for any given week on a first come, first

- serve basis.
- To receive the vacation credit your child can not be in attendance the full billing week, Monday through Friday.

Payment information:

- Parents will be billed on Friday for the upcoming week.
- Payments are due on the Monday of the week services are provided.
- We accept cash, check, auto draft or payment on the brightwheel app.
- Late Payment Fee will be added on Wednesday if account is not paid in full.

Payment Terms:

- Parents understand and agree to make timely payments for their child’s enrollment as outlined in the payment schedule above. In case of late payment, a late fee may be applied.

Withdrawal and Refunds:

- If Parents wish to withdraw their child from the Childcare Center, they must provide 2 weeks’ written or emailed notice. Tuition fees are non-refundable after the start of the enrollment period.

Health and Emergency:

- Parents must provide accurate and updated health and emergency contact information for their child. In case of a medical emergency, the Childcare Center is authorized to seek medical attention for the child.

Program Policies:

- Parents agree to abide by the policies and guidelines of Connect as outlined in the Parent Handbook.

Termination:

- Connect reserves the right to terminate this Agreement in the event of non-compliance with policies, unsafe behavior, or other valid reasons.

Governing Law:

- This Agreement shall be governed by and construed in accordance with the laws of Arkansas and Childcare licensing
